Community Health Plan of Washington Named One of Three Organizations to Offer Washington State Cascade Select Plans in 2023

Individuals and families in 20 counties will have more affordable, high-quality health care options

SEATTLE – September 7, 2022 – The [Washington State Health Care Authority](#) (HCA) has named [Community Health Plan of Washington \(CHPW\)](#), the Washington-headquartered managed care plan, as one of three “apparently successful bidders” in the state to provide [Cascade Select](#) health plans for individuals and family health plans for the coming year. These plans are part of Washington’s first-ever public option designed to increase the availability of quality, affordable health care coverage in the individual market.

“At CHPW, we believe no one should have to decide between food on their table and paying for health care. That is why CHPW offers Cascade Select plans, which are designed to support individuals and families who do not meet the requirements for publicly funded health plans Medicaid (income-based program called Apple Health in Washington) and Medicare (age and disability-based program),” said Melissa Stevens, Vice-President of Community Engagement & Growth of Community Health Plan of Washington. “By offering Cascade Select plans as part of our suite of health care offerings, we continue to provide Washingtonians affordable access to whole person, high-quality care.”

Beginning January 1, 2023, CHPW will offer Cascade Select plans to individuals and families in 20 counties, including Benton, Chelan, Douglas, Ferry, Franklin, Grant, Kittitas, Mason, Okanogan, Pierce, Snohomish, Thurston, Walla Walla, Yakima, Spokane, Jefferson, King, Kitsap, Lewis, and Whitman counties. Its Cascade Select plans offer low-cost options for local care and quality whole-person health benefits. These plans [cover more services](#) before meeting a deductible, including primary care visits, mental health services and generic drugs. Depending on income, there are also federal premium tax credits and cost-share reductions to lower premiums and out-of-pocket costs.

“Our award [of selecting CHPW to offer Cascade Select plans] is a reflection of all of the work that CHPW staff have done to make this program a success since this offering was first proposed in the WA State Legislature in 2019,” said The Washington State Health Care Authority. “This really is quite an achievement because this procurement was even more competitive than the initial RFP [request for proposal] in 2020. This time there were eight applicants and the total number of awardees was narrowed from five existing carriers to three announced as ASBs [apparently successful bidders] for 2023.”

The annual open enrollment period for 2023 coverage under Cascade Select plans will run from [November 1, 2022 through January 15, 2023](#) through the [Washington Health Plan Finder](#).
