Happy Fall! We hope you've been enjoying all the cozy things that come with the season, like we have at Community Health Plan of Washington (CHPW). We're excited to share some upcoming changes for 2024 and other resources to help you, help your clients get affordable, quality health care.

Open Enrollment for Cascade Select

Open Enrollment for 2024 individual and family health insurance plans through Washington Healthplanfinder starts November 1 and goes through January 15.

New this year: Anyone living in Washington, regardless of immigration status, can enroll in a health plan through Healthplanfinder.

And if their income is low (up to 250 percent of the federal poverty level) they can get financial help from the state through the Cascade Care Savings program. Most people who qualify for Cascade Care Savings can get a highquality plan for less than \$10 a month, when combined with Federal assistance!

- Our CHPW Individual & Family Cascade Select Plans are now available in 25 counties: Adams (new), Asotin (new), Benton, Chelan, Clallam (new), Columbia (new), Douglas, Ferry, Franklin, Grant, Jefferson, King, Kitsap, Kittitas, Lewis, Mason, Okanogan, Pierce, Snohomish, Spokane, Stevens (new), Thurston, Walla Walla, Whitman, and Yakima. CHPW has the lowest-cost Silver Cascade Care plan in 2024 in 19 of 25



It's Annual Enrollment Period (AEP) for Medicare!

Did you know? Some of your clients seeking health coverage may be "dual eligible" for both Medicaid and Medicare depending on their age and income. Dual-eligible clients pay less (as low as \$0 monthly premiums) and get more benefits.



Dual Complete Plan for Medicare enrollees who also qualify for full Medicaid (Apple Health) benefits, and the Dual Select Plan for those who are "partial dual-eligible" (only eligible for partial Medicaid benefits). With our popular Dual Complete Plan, we continue to serve the most vulnerable members of our communities.

Apple Health Redetermination

The Washington State Health Care Authority (HCA)'s ongoing verification process (Apple Health Redetermination), is back for good. The state continues

after it's terminated or reenroll if more time has passed.

to send notifications to Apple Health members who need to provide updated information to keep their health coverage, when their renewal period comes up. Unfortunately, we are continuing to see more and more people lose their insurance because they did not complete their renewal application, or they left out information on their application. It is not too late for them to get health

insurance. Apple Health recipients can complete their renewal up to 90 days

If a client no longer qualifies for Apple Health, they may still have affordable options. In 19 out of 25 counties, CHPW is offering the lowest-cost Silver Cascade Care plan – many plans are under \$10 per month for those that meet eligibility requirements.

You can direct Apple Health members with questions to our renewal help guide. Here they'll find more information and specific steps they can take to get their health insurance back or find a new plan.
